Metropolitan Action Institute, Executive Director and Trustee

Metropolitan Action Institute is a not-for-profit civil rights advocacy agency. An action and research institute, it aims to expand opportunities for minorities and for lower income households. Its former title was Suburban Action Institute.

As founder and Executive Director of this agency, my duties have included administration, research, education, lecturing, organizing, and participating in legal challenges to discriminatory practices.

My work with the organization has included these specific tasks:

- 1. Supervision of research projects
 - a. Legalizing Conversion of Single-Family Houses. A research contract with the federal Department of Housing and Urban Development (HUD). The purpose is to determine policies to make feasible the creation

- of accessory apartments in single-family housing units (1981-82).
- b. Inclusionary Revitalization. Under a contract with the New York State Division of Housing, MAI is to assist low-income residents in four revitalizing neighborhoods to gain a share of the jobs and wealth created from community renewal investments (1982).
- c. A Study of Growth and Segregation. An analysis of the changes in income distribution of families in the forty-four municipalities of Westchester County, New York. The study examined changes by income fifths during the period from 1950 to 1970 (1976).
- d. <u>Discrimination</u> by <u>Default</u>. A study of the civilrights performance of the Tri-State Regional Planning Commission. Study supported by the Fund for the City of New York (1976).
- e. A Study of Exclusion. A two-volume study of exclusionary zoning prepared for the Commonwealth of Pennsylvania Department of Community Affairs (1974).
- f. A Study of Zoning in Connecticut. Under a contract with the Connecticut Commission on Human Rights and Opportunities, an analysis was made of more than 160 zoning ordinances to determine the degree of their restrictiveness and to identify specific forms of exclusionary practices within that state (1978).
- g. Civil Rights Impact of Westway. A study that provided the basis for a complaint filed with the federal Department of Transportation alleging that the building of Westway would constitute a discriminatory act in violation of Title VI of the Civil Rights Act of 1964 (1980).
- h. Study of the Section 8 Housing Assistance Payments
 Program of Buffalo and Syracuse, New York. Prepared
 for the Eastern Regional Office of the U.S. Commission
 on Civil Rights. The study sought to determine
 the degree of discrimination in the Section 8
 Program (1980).
- i. Inclusionary Revitalization Program for Norwalk,
 Connecticut. A study for the City of Norwalk
 indicating means for including low-income community

residents in the City's revitalization efforts (1980).

j. A Plan for Hamilton Heights. A plan commissioned by the Harlem Commonwealth Council to revitalize one portion of Harlem (1979).

2. Zoning Litigation

Metropolitan Action was engaged in a number of test cases. Testified as an expert witness in cases involving: Madison, Bedminster, and Mahwah, New Jersey; Upper St. Clair, Pennsylvania; New Castle, Brookhaven, Oyster Bay, and North Salem, New York.

Current: preparing testimony for the first civil rights test of New Hampshire's zoning laws.

3. Corporate Relocation Studies

Metropolitan Action sought, under federal civil rights laws and regulations, to require corporations leaving New York City and relocating in the suburbs to act affirmatively to protect the jobs of minority employees. Studies were made and action taken in regard to: RCA, IBM, AT&T, GE, GT&E, Union Carbide, Stauffer Chemical, Western Electric.

4. Other Expert Testimony

- a. Employed by the U.S. Department of Justice to develop remedies in a housing discrimination case against Parma, Ohio. Testimoney cited by the 6th District Court of Appeals; remedies upheld (1981).
- b. Served as an expert witness in Hartford v. Hills, a case brought by the City of Hartford against HUD and seven suburbs surrounding Hartford, for alleged improper funding of the towns' housing and urban development projects.
- c. Suit by NAACP against New York City Board of Education in regard to Andrew Jackson High School: Metropolitan Action was instrumental in gaining a hearing before the Federal District Judge to have suburban Nassau County jurisdictions made codefendants with the City Board of Education.

5. Organizational Work

Created the Coalition for an Equitable Region, a fair housing civil rights coalition comprised of private and governmental antidiscrimination agencies from the

tri-state New York region.

Under a consulting contract with the Assistant Secretary for Fair Housing and Equal Opportunity of HUD, assisted in establishing a fair housing coalition in the Dallas-Forth Worth metropolitan region.

As part of a contract with HUD to expand housing opportunities in the suburbs, assisted in developing a fair housing coalition in the Clearwater-Saint Petersburg, Florida, metropolitan area.

6. Conference Organizer

Helped to organize numerous conferences on fair housing issues. Major conferences included as guest speakers Margaret Mead, Ralph Nader, Roy Wilkins, Mayor John Lindsay.

7. Fund-Raising Dinners

Metropolitan Action's honorees have included John Zucotti, Herman Badillo, Lewis Rudin, and Osborne Elliott.
